## INFORMATION & RESERVATION FORM

The Grand Tasting will be held on Friday, September 17, 2021, from 5:30 – 7:30 p.m. Table setup will begin at 3:00 pm. All wines presented must have a retail minimum value of \$30 (white) and \$50 (red.) By law, wine must be distributed in South Carolina to be sold on site. Please note that a minimum of four bottles per SKU presented is required. There is no fee for participation in the Grand Tasting. Reservation deadline is September 6, 2021.

The Public Tasting will be held on Saturday, September 18, 2021 from 12pm – 3 pm at Celebration Park. Booth setup will be from 10:30 – 11:30 am and wine pouring to the public is from noon – 3:00 pm. Please note, a minimum of four cases of samples per tent is required. Fees are \$425 per tent or \$250 per half tent. Reservation deadline is September 6, 2021.

Our featured retailer for the Grand Tasting and Public Tasting is The Hilton Head Wine and Food Festival.
